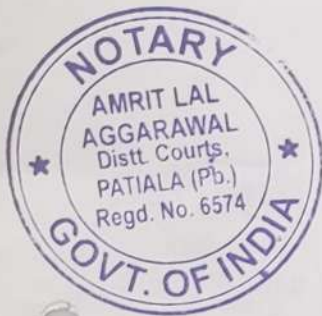
With reference to above noted subject.

2. On production of documents including affidavit

the recommendation of District Education Officer (S.S.)
Patiala, and Director, Education Department (S.S.),
Punjab, Chandigarh, the required No Objections Certificate
is issued by the Punjab Government on following terms
and conditions:-

1. In case any fact come to light on complaint/on
inspection in future that you have filed
application for obtaining No Objection Certificate
on the basis of wrong facts, and or that you have
not complied the instructions issued by Punjab
Government from time to time and not complied
terms and conditions mentioned in the affidavit,

then in such circumstance this No Objection Certificate can be withdrawn at any time.

2. It will be mandatory to teach Punjabi in your School upto Tenth Standard and the C.B.S.E., New Delhi shall make all efforts to take Punjabi Examination and it is also made clear that if it is not followed, then No Objection Certificate will be taken back immediately.
3. The management of the school will be responsible to pay salary and other allowances to its teaching staff and non-teaching staff as per Government Employees after taking affiliation from C.B.S.E. New Delhi. If it is not followed then the No Objection Certificate will be taken back immediately.
4. It will be make sure by you and your management that whenever any information is sought by District Education Officer of your District or by any Senior Officer of Education Department, then you will provide him the required information and will also provide him required co-operation.

2. Saint Xavier's International School, District Patiala the original Misal is hereby sent back.

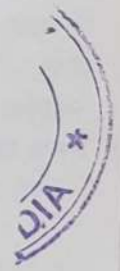
